President Dan Campbell opened the business meeting at noon, thanking Steve Childers, Tony Shahan and Karen Peterson for planning and hosting the event. He also thanked Bob McLaughlin for his service as chapter president. He noted the passing of faithful members Steve Spring and Terry Koller in March.

Minutes of the September 2016 meeting at Springfield Mill of Morris Arboretum in Philadelphia PA were approved as distributed.

Finance: The balance in the treasury is \$9,503.80. See Attachment B for a detailed report. The report will be placed on file for audit. The 2016 Year-end Audit was completed by Craig Sansonetti. All records are in good order.

Membership: Paid 2017 memberships include 44 chapter/SPOOM (\$10), 7 non-SPOOM members (\$15), 20 sustaining memberships (\$25), and 14 organizational memberships (\$50) for a membership total of 85.

SPOOM Mid-Atlantic Grant of \$605 was paid to the Mill at Anselma for clearing drain to creek.

2017 SPOOM Conference: The full SPOOM conference will be held October 11-14 featuring Lower Susquehanna Valley mill tours in York and Lancaster counties on Thursday and Friday with featured speakers on Saturday morning. The cost is \$175 for SPOOM members. The SPOOM MA Chapter Meeting will begin with lunch at the Agricultural Industrial Museum in York on Saturday followed by a tour of the museum. Query: I'm looking for a photo of a woolen mill as part of the history exhibit in the mill. **Response**: referred Ray Kinard (York Mill Researcher) who had an article on the Rouse Woolen Mill located in Violet Hill area and pictures of the Codorus Woolen Mill near Glenville and Dan Campbell: The photo of the Juniata Mill which you forwarded is typical of a Woolen Mill that was converted from a Grist Mill. Whether Glen Rock was a carding mill (processing wool into twisted strands), or a Weaving Mill (actually manufacturing items from the wool - such as using water-powered looms), or both, these processes were much more horizontal in nature. If Glen Rock was converted from a Grist Mill to a Woolen Mill, then the exterior would appear very much the same, but the interior workings would be greatly changed. Interior photos of a typical woolen carding or weaving operation might be more appropriate.

Response: Ivan Lufriu: the mill at Occoquan has historical significance in that it was perhaps the largest mill of its period, containing seven sets of mill stones. Any efforts to preserve the mill or property should be of National interest, although attempts to preserve the vista from the Mansion will mean a tough battle. Susan Langley: Mr. Houghton is the owner of **Rockledge Mansion**, built in 1758, which overlooks the mill town of **Occoquan, VA**. Since the property is privately owned, assistance is limited, but he should contact Dr. Ethel Eaton of the Virginia Department of Historic Resources. Virginia Dept of Historic Resources (VDHR) under Section 106 of the National Historic Preservation Act.
